Sibling Discount

A **10% tuition discount** is offered for the second child enrolled. This discount **does not apply** to the Enrollment Fee or Supplies Fee.

Supplies Fee: \$450 – Non-Refundable

(Due upon enrollment or no later than October 1st)

Payment Plans

Annual Payment (Paid in Full)

A **\$200 tuition credit** will be applied when the full academic year is paid in advance.

Monthly Payment Plan

Tuition payments are due on the **1st of each month**.

A **\$50 late fee** will be applied to payments received after the **5th of the month**.

- **Bank ACH:** 0.5% - 1% processing fee (maximum \$2 per transaction)

Returned payments (NSF) are subject to a **\$45 fee**.

Tuition Contract Terms & Conditions

1. All tuition and fees are **non-refundable**.
2. Tuition must be paid in full and on time for a child to attend school. If payment is not received by the **5th of the month**, the student may not attend until the account is current.
3. A **\$50 late fee** applies to payments received after the 5th of the month.
4. **Late Pick-Up Fees:**

- 3:00 p.m. – 4:00 p.m.: \$35
 - 4:00 p.m. – 5:30 p.m.: \$45
 - After 5:30 p.m.: **\$15 for the first 5 minutes plus \$2 per additional minute**
 - Children not picked up by **6:00 p.m.** may result in notification of local authorities.
5. Families withdrawing a child during the school year are responsible for tuition for the **current enrolled month**.
 6. International Montessori Academy reserves the right to **suspend or terminate enrollment** if financial obligations or school policies are not met.
